# **Contest Rules and Regulations**

Sugar Shack – La Récolte de St-Méthode Mars 3 to April 13, 2025

1. **Sugar Shack – La Récolte de St-Méthode** contest (the "Contest") is sponsored and administered by Boulangerie St-Méthode (the "Organizer"). It will run in Canada from 10:00 A.M. EST on March 3, 2025 to 11:59 P.M. EDT on April 13, 2025.

#### **ELIGIBILITY**

2. The Contest is open to all residents of Canada who have reached the legal age of majority in their province or territory of residence at the time they enter the Contest. Directors, officers, and employees of Boulangerie St-Méthode or any of its affiliated companies and organizations, as well as members of their immediate families (father, mother, brother, sister, son, daughter) and persons who reside in the same household, are not eligible to enter the Contest.

#### **HOW TO ENTER**

- 3. To enter the Contest, Entrants must complete the official Contest entry form (the "Entry Form") available on the www.printempsstmethode.com website, including their first and last names, email address, street address, phone number, sex, age, and the unique alphanumeric product code found on participating Le Royal de St-Méthode product—Le Royal Bread (650 g)—sold only at participating retailers in Canada. Each duly completed Entry Form counts as one (1) chance to win. No purchase required.
- 4. To enter by mail, print and fill out the official Entry Form available online OR write up an information sheet including details corresponding to those on the Entry Form (that is, first and last names, email address, street address, phone number, sex, age and the unique alphanumeric product code found on participating Le Royal de St-Méthode product—Le Royal Bread (650 g)—sold only at participating retailers in Canada. Mail the handwritten entry in an envelope bearing sufficient postage to: Orangetango, Contest Le temps des sucres Boulangerie St-Méthode, 3451, rue Masson Montréal (Québec) H1X 1R8.
  - 4.1. Your entry must be postmarked no later than April 20, 2025 at 11:59 P.M. EDT. Limit of one (1) Entry Form or handwritten entry per envelope. Illegible or incomplete entries will be disqualified. Photocopies, documents produced on a computer, mechanical reproductions, and mass submissions are ineligible.

- 5. To be valid, Entry Forms must be submitted by 11:59 P.M. EDT on April 20, 2025. Participation is limited to one (1) electronic Entry Form per Entrant per day. A one-day period lasts from 12:00 A.M. (midnight) to 11:59 P.M. Entrants can only use one email address to enter the Contest, no matter how many email addresses they may have. Entry Forms generated by script, macro, machine replication, programming, or any other automated methods are prohibited and will automatically be declared ineligible. If an Entrant submits more than one Entry Form on the same day, he or she will automatically be disqualified, with all of the Entrant's Entry Forms declared ineligible.
- 6. All Entry Forms received become the property of Boulangerie St-Méthode and will not be returned to the Entrants. The odds of winning a Prize will directly depend on the number of eligible Entry Forms received.

### **PRIZES**

- 7. There is a total of twenty (20) prizes to be won. Each prize consists of one (1) check payment of \$500 made payable to each of the winners. The total value of the twenty (20) prizes to be won is CAD \$10,000. The Prizes will be delivered to each of the twenty (20) winners by mail.
- 8. The following conditions apply to the Prize:
  - 8.1. The Prize is not transferable and must be accepted as is. It cannot be combined with any other promotion underway at the time it is awarded.
  - 8.2. If the winner is unable to accept the Prize as awarded, Boulangerie St-Méthode will offer no compensation or substitution.
  - 8.3 The winners may keep the entire payment for personal use.

## **DRAW**

9. At 10:00 A.M. EDT, on Monday, April 21, 2025, twenty (20) Entry Forms will be randomly drawn from among all eligible Entries received.

The draw will be held at Orangetango's offices located at 3451, rue Masson Montréal (Québec) H1X 1R8.

- 10. The persons whose names are on the first twenty (20) randomly drawn Entry Forms found to comply with all the conditions set out in these Rules and Regulations will be declared the Prize winners.
- 11. Orangetango will contact the Prize winners by phone within seven (7) business days following the draw. The Prize winners must read and accept the conditions of the Declaration and Waiver of Liability Form and return a signed copy by 11:59 P.M. EDT on May 2, 2025.

12. If a Prize winner does not return a completed and signed copy of the Declaration and Waiver of Liability Form to Orangetango before the deadline of May 2, 2025, or is unable to accept the Prize for any reason, he or she will lose the Prize, which may be awarded to another Entrant at the discretion of the Organizer.

## **GENERAL CONDITIONS**

- 13. To be declared a Prize winner, randomly drawn Entrants must correctly answer a mathematical skill-testing question found on the Declaration and Waiver of Liability Form.
- 14. Prize winners must authorize the use of their names and photographs for any further publicity carried out in connection with this Contest, with no additional compensation.
